It is incumbent on clients to pay Courier Local and International (Pty) Ltd trading as Airfreight Africa the total invoiced amount even though queries may have been raised with Customs, Airlines, Railways or other third parties. Courier Local and International (Pty) Ltd trading as Airfreight Africa, as agents, will use their best endeavours to obtain refunds quickly from third parties.
